Darnall's Gun Range Participant Agreement, Release and Acknowledgement of Risk

In Consideration of the services of DARNALL GUN WORKS & RANGES, their agents, landlords, owners, officers, volunteers, participants, employees and all other persons or entitles acting in any capacity on their behalf (hereinafter collectively referred to as "Range")., As well as the NRA Youth Camp and the NRA. I hereby agree to release and discharge the Range, the NRA Youth Camp and the NRA, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that shooting guns entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: Being shot, dying or becoming permanently injured and or impaired physically from the discharge of bullets.

Furthermore, Range employees and volunteers have difficult jobs to perform. They seek safety, but are not infallible. They might be ignorant of a participants fitness or abilities. They may give inadequate warnings or instructions and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participating in this activity is purely voluntary and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Range, the NRA Youth Camp, and the NRA from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of the Ranges equipment or facilities, including any such claims which allege negligent acts or omissions or the Range.
4. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly by any such condition.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in thi activity, I may be found by a court of law to hav waived my right to maintain a lawsuit against the Range, the NRA Youth Camp, and NRA on the basis of any claim from which I have released them herein.
